The agenda meeting of the Northampton Township Board of Supervisors was held at 6:30 pm.

The regular business meeting of the Northampton Township Board of Supervisors was called to order at 7:30 p.m.

PLEDGE OF ALLEGIANCE

Chairman Moore led the Pledge of Allegiance and held a moment of silence in support of military and emergency services personnel.

SPECIAL PRESENTATION

Saint Katherine Drexel Regional Catholic School

Ms. Laura Clark, Principal of St. Katherine Drexel stated in the closing of Police week, they had invited officers to the school where they presented the Police Department with a plaque and thanked them for their service. Tonight they presented Chief Clark with a framed picture taken that day and thanked him and the Police Department for all that they do on a daily basis.

Pollutant Reduction Plan Update

Ms. Amanda Fuller, of Gilmore Associates and the Township Engineer, stated the the Environmental Protection Agency and the Pennsylvania Department of Environmental Protection regulate discharges into the Neshaminy Creek via Northampton Township's Municipal Separate Storm Sewer System (MS4) and requires the Township to hold a permit for these discharges. The permit is required to be renewed every 5 years, and Northampton received approval on its permit renewal from the PADEP on May 15, 2019. This began the 5-year timeline for complying with the new regulations established during this permit cycle, which includes reducing sediment and phosphorus pollutants in the Neshaminy Creek. The Township has proposed to retrofit several stormwater basins throughout the Township in order to comply with this regulation and is currently seeking grant opportunities to fund construction.

PUBLIC COMMENT

None was heard.

CONSENT ITEMS

The Board meeting minutes of May 22, 2019, was approved by unanimous consent.

ACCOUNTS PAYABLE

The accounts payable for May 8, 2019, in the amount of \$591,901.02, and May 22, 2019, in the amount of \$1,474,604.05, was approved by unanimous consent.

NEW BUSINESS

<u>Consider Resolution Authorizing a Grant Application with the Commonwealth Watershed</u> <u>Restoration Protection Program to Retrofit the Detention Basin on Jennifer Lane and Make</u> <u>Improvements to the Pond on Norton Drive</u>

Ms. Silver outlined the resolution and stated the Administration recommends the Township apply for a grant through the Commonwealth Financing Authority Watershed Restoration Program to naturalize the detention basin on Jennifer Lane as part of its obligations under the Municipal Separate Stormwater System (MS4) permit requirements. As you know, the Township has five years from the permit issuance date to complete naturalization of approximately six detention basins to meet the requirements for sediment and phosphorus reduction in the Neshaminy watershed, encompassing most of the Township's land area.

The Eagle Valley Basin and Norton Pond Restoration project will retrofit the basin on Jennifer Lane and will also remove the sediment build up in Norton Pond. The basin will be retrofitted with new plantings to reduce runoff, bio-retention areas will be installed to improve water

quality, and stormwater management improvements will reduce sediment. The project will also restore Norton Pond to its original depth.

The project is intended to protect the Ironworks Watershed and is planned to be used as credit towards the MS4 requirements. The total projected cost is \$250,000. The grant application is for \$212,500 and requires a 15% match from the Township of \$37,500.

The grant program requires a Resolution from the governing body authorizing an individual to file the application on behalf of the Township. A draft Resolution is attached for your review.

A motion was made and seconded (Silver-O'Donnell) to adopt Resolution R-19-8 authorizing the Township Manager to file a grant application with the Commonwealth Financing Authority's Watershed Restoration Protection Program to naturalize the detention basin on Jennifer Lane and restore the depth to Norton Pond, and to execute all documents required by the grant program.

Chairman Moore called for public and Board comment. None was heard.

Motion Passed 5-0.

Consider Bids for Civic Center Improvements

Dr. Rose stated the Bids were opened on May 13, 2019, for the second phase of the Civic Center Improvement Project. There were a total of 8 bids received. Five bids were for the site improvements and 3 bids were for electrical work associated with parking lot lighting.

The project consists of grading and seeding two soccer fields, installing new trails that include a connection to Tyler State Park, installation of bleacher pads for ADA compliance, paving the access drive, reconfiguring, enlarging and paving the middle parking lot, reconstructing and paving the rear parking lot, installation of parking lot lighting, and stormwater management.

Dr. Rose explained the Administration evaluated 4 options based on the bids received and recommends awarding a contract to Ankiewicz Enterprises, Tamaqua, Pa in the amount of \$867,196.10. This includes the Base Bid, Alternate Bid #1, and Deduct Bid #1. Under this proposal, the Public Works Department will pave the access drive as part of its paving program this year.

The Administration further recommends awarding a contract to Bonavitacola Electrical, Inc. in the amount of \$66,687.70. This includes the Base Bid and Alternate Bid #1.

Dr. Rose noted based on these recommendations, the total bid awards will be \$933,883.80. Our budget for this project is \$1,024,000.

A motion was made and seconded (Rose-Selisker) to award contracts for Civic Center improvements to Ankiewicz Enterprises, Inc. in the bid amount of \$867,196.10 to include the Base Bid, Alternate Bid #1, and Deduct Bid #1, and to Bonavitacola Electrical, Inc. in the bid amount of \$66,687.70 to include the Base Electrical Bid, and Alternate Electrical Bid #1, and to authorize the Township Manager to execute all contracts associated with this project.

Chairman Moore called for public and Board comment. None was heard.

Motion Passed 5-0.

Consider Bids for Road Milling

Mr. Selisker noted the bids for the 2019 Roadway Milling Project were opened on May 14, 2019, through the Penn Bid system. A total of six (6) bids were received for milling thirteen (13) roadways throughout the Township. The bid results are as follows:

A motion was made and seconded (Selisker-Silver) to award a bid to Haines Paving, Inc., of Rushland, PA for roadway milling in the amount of \$63,910.17 based on the quantities outlined in the bid documents and specifications for roadway milling bids.

Authorize Sale of Surplus Property

Mr. O'Donnell stated, Gary Crossland, Public Works Director has indicated that we are able to sell surplus items. These items are expected to be valued at more than \$2,000 and as a result, can only be sold when authorized by the Board of Supervisors. The Administration requests your approval to sell this equipment at public auction on the Municibid website.

A motion was made and seconded (O'Donnell-Rose) to authorize the Township Administration to sell surplus equipment at public auction as recommended by the Department of Public Works in a memorandum dated May 15, 2019.

Chairman Moore called for Board and public comment. None was heard.

Motion passed 5-0.
