The regular business meeting of the Northampton Township Board of Supervisors was called to order at 7:45 p.m.

Chairman Moore led the Pledge of Allegiance and held a moment of silence in support of military and emergency services personnel.

## SPECIAL PRESENTATION

### **Update on Northampton Day Community Festival**

Mrs. Silver provided an update on the upcoming Northampton Day Community Festival coming to Richboro on May 5, 2018, Mrs. Silver outlined the events, activities, sponsors, and food options that will be available.

### **Spring Mill Country Club Rezoning Request**

Chairman Moore stated the Township received a formal rezoning request for the Spring Mill Country Club on April 24, 2018. The Board is expected to hear this request on May 23, 2018.

Chairman Moore called for public comment:

The following residents spoke in favor of the Spring Mill rezoning request and spoke on the process and approach to find an amendable solution for all parties involved.

Chairman Moore called for Board comment.

The Board unanimously agreed with the outcome and echoed the importance of preserving open space.

### Update on Due Diligence to Acquire Northampton Valley Country Club

Chairman Moore outlined the proposal of acquiring the Northampton Valley Country Club and noted the Board is still in the due diligence phase and will not be signing anything at tonight's meeting.

A letter of intent was signed at the last meeting to purchase the Northampton Valley Country Club; this includes running the golf course and catering business. The purchase price is \$12.5 million dollars. A copy of the signed letter of intent is on the Township website.

Chairman Moore noted, everything as far as running the Country Club would stay the same. All employees will be kept intact. This letter of intent gives the Township 90 days to perform their due diligence and if interest rates rise about 4%, the Township can back out of the deal. This letter of intent is a structural non-binding agreement.

Chairman Moore called upon Kurt Schroeder, the Township Engineer to explain where the Township is in the process. Mr. Schroeder stated his firm has met with Management for the Country Club, and is in the process of a site and facilities assessment, surveying work, reviewing mortgages, liens, performing boundary, and encroachment surveys. An Environmental review that includes, but not limited to, water and sewer services, wells, pumps, ponds, integrity of existing trees, asphalt and parking lots. Mr. Schroeder stated his firm would continue to work with Professionals and Administrators to be able to give a full assessment of this property.

Mr. Pellegrino stated in addition to the work Gilmore and Associates is performing; the Administration is working with other specialized consultants as well. As an example, a professional in this field is looking at the pool.

Mr. Pizzo stated his firm is working on the agreement of sale, reviewing titles, leases, looking for any judgements or liens on the property. His firm is also in contact with Bond Counsel, inquiring on a liquor license for the property, this will be a blanket license since Municipalities fall under a separate license for these types of facilities.

Chairman Moore called for Board comment.

Each of the Board members took turns discussing the pros and cons as they look at this purchase.

Mrs. Silver, Mr. Weinstein, and Mr. O'Donnell feels the process is moving too fast and raised questions on projections completed so far. Mr. Pellegrino and Mr. Moore fielded questions and provided answers based on information that has been provided so far.

Dr. Rose reiterated the necessity to maintain open space and that by a developer taking over she believes it will increase traffic and taxes. Mrs. Silver and Chairman Moore agreed.

Chairman Moore called for public comment.

Gary Skylar, owner of Northampton Valley Country Club, stated he has had offers by several developers, he would prefer to maintain it as open space, as it has been in their family since 1963 and would preserve his heritage. Mr. Skylar noted his business creates seasonal jobs and could have up to 150 employees.

## **PUBLIC HEARINGS**

### **Consider Adoption of Comprehensive Plan Update**

Chairman Moore opened the hearing at 10:15 pm.

Chairman Moore explained the Comprehensive Plan and noted that it is a guiding plan not a law. The Board has decided it needs more time to review this matter and will be taking public comment for any further concerns or input.

Chairman Moore called for and public comment.

Christiana Giamio, part owner of Guiseppe's restaurant in Richboro. Mrs. Giamio asked the Board to send out letter and possibly copies of the plan to business owners that would be impacted by this plan. She stated she read the plan and it states the reconfiguration of Guiseppe's parking lot, it is a concern she was not notified of this request.

A motion was made and seconded (Moore-O'Donnell) to continue the adoption of the Comprehensive Plan Update to the July 25, 2018 Board of Supervisors Meeting.

Mrs. Silver asked if Mrs. Giamio's request is feasible. The Administration stated it would send out a letter to the business's directing them to the website or to come into the Township Building to review the document.

Chairman Moore closed the hearing at 10:22 pm.

### **NEW BUSINESS**

### **Consider Bids for Police Station Construction**

Mr. O'Donnell stated bids for the General Construction and Fire Protection Systems were opened on April 12 through the Penn Bid system for construction of our new police facility. A total of six General Construction bids were received with each providing alternate bids for Fire Protection. In addition, two bids were received for Fire Protection as stand-alone contracts. This was done to ensure we received pricing for fire protection this time around.

A summary of the results for each prime bid follows:

## **General Construction with Alternate Fire Protection**

If contracts are approved tonight, the Architect will proceed with processing Letters of Intent and contracts to each company awarded a bid.

In Summary, the Administration recommends the following actions:

- 1. Award a contract to Gordon H. Baver, Inc. for the General Construction in the amount of \$3,830,038 <u>AND</u> their alternate bid for Fire Protection Construction in the amount of \$121,900.
- 2. Reject all bids for Fire Protection Construction.

A motion was made and seconded (O'Donnell-Weinstein) to award a bid to Gordon H. Baver, Inc. for General Construction in the base bid amount of \$3,830,038 and for Fire Protection Construction in the amount of the alternate bid price of \$121,900 for the new Police Station on Township Road as outlined in the bid documents and specifications. In addition, I move to reject all base bids for Fire Protection Construction.

Chairman Moore called for Board and public comment. None was heard.

Mr. Weinstein stated he believes Polder Drive should have been on the list for paving and it was stated it is being done.
