#### Land Development Process Q&A

O: What Boards and Commissions are involved with deciding a plan approval?

A: The **Board of Supervisors** serves as the legislative body of the **Township**, setting policy, enacting ordinances and resolutions, adopting budgets, and levying taxes. The Board of Supervisors plays the central role in the township government. Article 15 of the Second Class Township Code (Pennsylvania Law that regulates

townships) places general supervision of the affairs of the township in the hands of the board of supervisors. The board serves as the legislative body of the township, setting policy, enacting ordinances and resolutions, adopting budgets, and levying taxes.

A: The **Planning Commission** is a group of citizens whose primary role is to advise the Board of Supervisors on issues and policies related to planning, land use regulation, and community development including land development plans. The planning commission is advisory only and the Board of Supervisors are not bound to their recommendations.

A: The **Zoning Hearing Board** is a judicial group of citizens appointed by the Board of Supervisors that provides the legal mechanism for considering appeals from property owners seeking variances from zoning requirements, special exceptions, interpretations of the zoning regulations, and challenges of the validity of land use determinations.

The Zoning Hearing Board's role, which is set out in Article IX of the Pennsylvania Municipalities Planning Code is to interpret and apply the current Township Zoning Ordinance (local zoning laws) to an application.

The Zoning Hearing Board is NOT permitted to ignore, alter or rewrite the Zoning Ordinance.


It is also important to note that the Zoning Hearing Board does not enforce the Zoning Ordinance or violations, or even its decisions. That is the job of the Township's Zoning Officer and Board of Supervisors. Once the Zoning Hearing Board makes its decisions, its role at the Township level is completed.

Q: What is a use by right in a zoning ordinance?

A: A use by right is a designation in a zoning district that authorizes an applicant to obtain a zoning permit from the zoning officer for that use provided they meet the criteria in the zoning ordinance for that particular district. A use by right does not require any additional hearings or approvals.


- **0**: What is a conditional use?
- A: A conditional use is when a particular use is permitted in a specific zoning district, but the applicant must first apply to the Board of Supervisors and go through a hearing process before approval is granted. The board may attach reasonable conditions to the approved application and may only reject the application if it does not meet the criteria in the zoning ordinance.
  - **Q**: What is a special exception how is it different from a conditional use?
- A: A special exception is also when a particular use is permitted in a specific zoning district, but the applicant must first ask the zoning hearing board for approval and go through a hearing process. The Zoning Hearing Board may attach reasonable conditions to an approved application. The board may only reject the proposed use if the applicant does not meet the criteria in the zoning ordinance.
  - **0**: What is a variance?
- A: A variance is a relief that is granted under the provisions of the zoning ordinance and authorizes a property owner to use his land for something that may not otherwise be allowed because of the location, size, shape, or other attributes of the property. Only the Zoning Hearing Board may grant a variance to a property owner after holding a public hearing.
  - Q: May the Board of Supervisors overturn a decision of the Zoning Hearing Board if it doesn't agree with the decision?
- A: No. If the Board of Supervisors does not agree with a decision of the Zoning Hearing Board, it must appeal the decision to the County Court of Common Pleas.
  - Q: May the Board of Supervisors appeal a decision of the Zoning Hearing Board if it disagrees with that decision.
  - A: Yes
  - **Q**: How can we learn more about special exceptions, conditional uses, and variances?
- A: The Governor's Center for Local Government Services has several useful publications on the Municipalities Planning Code and the planning process, which are available free of charge online. To view these publications, go to www.dced.pa.gov and choose "Local Government", and the "Publications and Documents". The free downloads are available by choosing "Library".

#### Pennsylvania's "Move Over" Law Updates Take Effect April 27

Nationally, 2 first responders are struck by vehicles every day! In 2020, 46 responders were killed nationwide, with 2 in Pennsylvania. (Source: ResponderSafety.com)

On April 27, 2021, Pennsylvania's updated "Move Over" Law becomes effective with significant penalties. The law requires drivers approaching an emergency response area who are unable to safely merge into a lane further away from the response area, to slow to at least 20 mph less than the posted speed limit. An emergency response area is where an emergency vehicle has its lights flashing, or where road crews or emergency responders have lighted flares, posted signs, or try to warn travelers.



So, what does this mean? If you are driving on a multilane road and there is an incident on the shoulder, you should **MOVE OVER** into a lane that allows a "buffer lane" between you and the incident. If you are unable to do this safely, you need to **SLOW DOWN** to a speed that is 20 MPH less than the posted speed. Penalties are steep... 2 points, plus \$500 for the first offense, \$1000 for the second, and \$2000 for the third plus a 90-day license suspension. Police officers will be aggressively enforcing this law.

Drivers approaching an emergency response area must safely merge into a lane further away from the response area.

#### Trash Collection Rules and Regulations

#### Trash is collected once (1) a week:

- Each household is limited to twelve (12) bags or cans of trash per collection.
- The collection starts at 6 am, so put the trash to the curb the night before, or plan accordingly.
- All trash should be bagged, <u>Do Not</u> put out trash in paper bags, cardboard boxes, or in containers smaller than 20 gallons or larger than 32 gallons. These cause litter.
- Trash, Recycling, and One (1) Bulk Item are on the same service day.

#### • Bulk Item Collection:

- Bulk items can include furniture, carpets, appliances, tree limbs, or trunks larger than 3" in diameter (cannot be longer than 36") certain restrictions apply.
- Carpets and padding must be cut into 3-foot widths, rolled, tied, or taped.
- Windows, mirrors, glass panels in doors, etc., must be taped in a crisscross pattern to prevent breakage.
- Only 10 rolls of carpet/padding per pick up.
- Mattresses and box springs must be wrapped in plastic. (See additional news article on page 10.)

#### Bulk Items to be considered Hazardous:

- Refrigerators, air conditioners, and humidifiers contain <u>Freon</u> which is considered Hazardous. *You must call to schedule a pick-up at* **1-800-432-1616**. There is **no charge** for this service.

#### Leaf and Yard Waste Collection

April 1st to December 15th. Yard waste is collected the day following the collection of trash/recycling. Always use biodegradable 30-gallon paper bags or trash containers that do not weigh more than 50 pounds when full. Yard waste in plastic bags will not be collected. Tree branches and shrubbery must be no more than 36" long and less than 3 inches in diameter. They must be bundled and tied, taped, or put in biodegradable bags. Branches or shrubbery cannot extend over the top of the can or bag.

#### • Medical Waste Disposal:

- Syringes and materials used for medical treatment: Place in a heavy plastic container, tape lid shut, and place in the regular trash. (**Not in Recyclables**).

#### • What to do if any of the above pick-ups were missed:

Contact the Township at 215-357-6800 or via email at receptionist@nhtwp.org. Include your name, address, and phone number. The
Township is in direct contact with a Route Supervisor and will reach out to the issue resolved as quickly as possible. The Township
requests that once you notify us of your situation, leave whatever was not taken at the curb. If J.P. Mascaro & Sons are behind in
collections they sometimes work late and on weekends to get items collected.

The Township thanks you in advance for your patience and cooperation in these matters.

#### Why can't I put my television and other electronics at the curb?

A Pennsylvania Department of Environmental Protection (DEP) Mandate prohibits curbside collection of Electronics (desktop computers, monitors, laptops, computer peripherals, and televisions)

On January 24, 2013, a disposal ban on covered devices went into effect in Pennsylvania, making it illegal to dispose of a covered device (The term includes desktop computers, monitors, laptops, computer peripherals, and televisions) with their municipal solid waste. These devices and their components must be properly recycled and may not be taken to, or accepted by, landfills or other solid waste disposal facilities for disposal.



The following recycle centers, retail, and nonprofit outlets recycle electronic items. Other recycling centers will be posted on the Township website www.northamptontownship.com as they become available. You can also call 215-357-6800 for information.

#### Why bring your household hazardous wastes to a scheduled event?

Household products containing toxic chemicals, like pesticides, oil-based paints, solvents, cleaning products, weed killers and automotive batteries can be a threat to people and the environment if improperly discarded. Never throw these materials into the trash, as the toxic chemicals may harm sanitation workers, or result in fires in collection vehicles. It is also not safe to pour them into a sink or storm drain as they can end up in the environment polluting the air, water, or soil.

# Proper Bulk Item Mattress and Box Spring Disposal



Mattresses and box springs must be bagged and sealed in plastic mattress bags when placed curbside



Residents may continue to set out bulk furniture, such as sofas for collection at curbside, in most cases, up to one item per week. Mattresses and box springs must be bagged and sealed in plastic mattress bags when placed curbside. Items may be set out on your regularly scheduled trash/bulk service day. All mattresses and box springs must now be wrapped in plastic before collection. Recent infestations of bed bugs have spread from mattresses to employees as they make curbside pickups.







These photos are examples of approved mattress disposal bags. You can find mattress disposal bags at most major retailers and home improvement stores, such as Home Depot, Lowe's, Walmart, Amazon.com, etc.









#### Finance Department: Understanding Your Local Taxes!

Local Service Tax (LST): Businesses with employees, partners, S corporation shareholders and self-employed individuals are required to file Local Service Tax (LST) returns with Keystone Collections Group. The LST is a \$52 per person/per year tax imposed on anyone working or generating net profits within the TWP. Employers are responsible for withholding the tax from employees and remitting it to Keystone Collections Group quarterly. Self-employed individuals and business owners must pay their own LST in the first quarter. The LST also applies to employees working remotely from home within the TWP. Individuals earning less than \$12,000 within one year are exempt.

Employers should register with Keystone Collections Group in order to remit properly. Delinguent LST is collected by Keystone Collections Group.

**Earned Income Tax (EIT):** Businesses with employees, partners, S corporation shareholders and self-employed individuals are required to file quarterly Earned Income Tax (EIT) returns with Keystone Collections Group. The EIT is a 1% tax based on "earned income". Employers are responsible for withholding the tax from employees and remitting to Keystone Collections Group quarterly. Self-employed individuals and

business owners must pay their own EIT by remitting quarterly estimated payments with a quarterly voucher. The EIT also applies to employees working remotely from home within the TWP.

Employers should register with Keystone Collections Group in order to remit properly. Although all collection is done by Keystone, this tax is ultimately sent to the resident municipality of the employee. Delinquent EIT is collected by Keystone Collections Group.

Real Estate Tax: Our Tax Collector (Vincent Deon) is responsible for sending annual Real Estate Tax notices to all residents. Notices for Bucks County RE Tax and Township RE Tax & Refuse Fee are usually sent in February for the calendar year. Notices for Council Rock School District RE Tax are sent in July for their fiscal year. Residents for whom a mortgage company pays the real estate tax, must send these tax notices accordingly. The Tax Collector does not send notices to mortgage companies. Delinquent Real Estate Taxes are collected by the County. Delinquent Refuse Fees are collected by G.H. Harris & Company. Did you know: Northampton Township receives only eleven (11%) percent of you real estate tax.

When mowing grass please take precautions not to discharge cut grass into the roadway. Cut grass in the roadway can cause clogging of the storm sewer inlets and pipes. Grass entering the stormwater infrastructure will contribute to sediment in creeks and streams. Equally important, grass discharge into the street is a violation of the Northampton Township Property Maintenance Code. A fine to the property owner can result by not adhering to this Code.

#### From the Building and Codes Department

Frequently, our department receives phone calls from residents about paint markings on the roadway or lawn area in front of their house. What exactly are these marks and what do the colors mean? It is all related to a Pennsylvania One Call.

Whenever there is excavation or digging, it is the law that a Pennsylvania One Call must be made by dialing 8-1-1. When this call is made, all utility companies come out and identify their particular utility by color. For example, water is blue, electric is red, cable is orange, etc. Due to the frequency of requests for service, many of these calls are related to the cable companies.

The marks that you see are the locations of these particular utilities. In many cases, they are in the roadway itself. Many other times, however, the utilities are located in the right-of-way adjacent to the curb. Township and State right-of-ways extend beyond the roadway and curb. In most residential developments, the right-of-way extends 10 feet beyond the curb. In response to many questions that we receive, the markings are not on private property, but rather in the right-of-way that is designated for these utilities. In addition, there are often easements that run through private property to carry utilities as well.

If you have any questions, feel free to contact the Building and Codes Department at 215-355-3883. Most importantly, if you are doing ANY digging or excavation on your property, you are required to make a Pennsylvania One Call by dialing 8-1-1. It can prevent major problems with a simple phone call. It's also the law!

#### **Development Status Update**

The following are the development projects that have begun construction in Northampton Township...

#### **GIANT**

A new 50,340 square-foot Giant at the Richboro Plaza Shopping Center will be constructed in place of the former Murray's Market.



#### **STAR SCHOOL**

Council Rock School District is constructing a new 27,073 square foot building for the STAR School on the 38-acre site adjacent to the existing Richboro Middle School.

#### **SPRING MILL COUNTRY CLUB**

Spring Mill Country Club is currently zoned REC - Recreation, which permits development in accordance with the standards of the R-1 zoning district. As a result, single-family detached homes were originally proposed, which would have seen the development of the golf course. Due to a collaborative effort with the developer, neighbors, and the Township, however, the zoning was changed to permit 175 townhouses on the front of the golf course property on Jacksonville Road. As part of this agreement, the golf course will not be developed and will have a conservation easement attached to it that will preserve it in perpetuity. In total, 155 acres constitutes the golf course area that will be preserved while 30 acres will be devoted to the area of the townhouse development.

#### **WAVERLY SUBDIVISION**

Southwest of the intersection of East Holland Road and Belmont Way, this development will encompass 15 single-family detached dwellings ranging from lot sizes of 40,001 to 74,690 square feet.

- 5. The number of recipients will be limited to a maximum of two per year; there may be years when no individuals are nominated and/ or no nominees are selected to receive this award




#### Northampton Township Police Department

#### NORTHAMPTON TOWNSHIP FIRE DEPARTMENT



It's always important to be mindful of fire safety around the house. Include a fire safety checklist to your routine.

Smoke and Carbon Monoxide Alarms - Replace the battery and test them monthly. Smoke alarms should be replaced every 10 years and Carbon monoxide detectors replaced according to the manufacturer's instructions.

**Address Clearly Visible -** Can we find you? Make sure your house numbers are clearly visible, proper size and not obstructed.

**Grills** - look for potential leaks or damage to hose, tanks and connections. Use the grill in an open, outdoor area away from anything combustible and clean it after each use.

**Electrical Cords** - Inspect the electrical cords in your home and replace any that are worn or damaged. Avoid using a single outlet for multiple electrical cords.

**Clothes Dryer -** Excess lint could cause a dryer fire. The lint trap should be cleaned after every use. The vent hose is another area where lint can accumulate.

**Create an escape plan -** You should have an escape plan. Review the plan with your family and practice it during the nice weather.

#### From The Office of the Fire Marshal

#### **Burning Ordinance**

Northampton Township code prohibits the burning of brush, leaves, yard waste, trash, and other materials. Specific regulations for the operation of fire pits for the recreational enjoyment of your home are noted below. Please note that the operation of fire pits in town-home communities is prohibited due to the inability to maintain required clearances to safely operate these units.

#### **Backyard Fire Pits**

The Township's ordinance allows for outdoor burning in conjunction with normal heating or cooking requirements in a

single-family home. Be cautious, though: These units should only be used under common sense and the item's manufacturer's instructions.

Please note that backyard fire pits discharge smoke at ground level. Be considerate of your neighbors as they are commonly used during the summer months when your neighbors may be outside or have their windows open. Also, backyard fire pits must be constantly supervised so that residents will not unnecessarily call the fire department.

\*Any backyard fire deemed to be a nuisance will be extinguished.

#### Successful Grant Funding Continues!

The Township has been successful in obtaining grant funding for many Township projects and will look to continue this success in 2021. Grants reduce the burden on Northampton taxpayers and offset the need for additional real estate taxes to fund these important community projects. In the last five (5) years the Township has received approximately \$18.5 in grant funding. In large part due to the Boards' commitment to community-driven, long-range planning efforts.

#### **Recent awards:**

\$500K – Richboro Sidewalk and ADA Improvements Along Second Street Pike (SR0232) & Newtown Richboro Road (SR0332)

\$50K - Front Walkway Replacement - Administration Building Improving ADA Access

\$25K — Covid-19 grant from PA used to purchase 2 disinfection units
The Township received a \$500,000 grant for the Richboro sidewalk project from the Commonwealth's Multi-Modal Fund program and is required to provide 30% in matching funds. Our matching requirement will be satisfied by funding the engineering design, bidding, and construction observation costs, most of which have already been paid using previously received fees collected in lieu of constructing sidewalks on certain development projects.

The project consists of installing Richboro 2000 style sidewalks

on certain properties along Second Street Pike where none currently exist to improve pedestrian safety and walkability in the downtown area, consistent with recommendations in the Richboro Village Master Plan.

The Township has \$520,000 budgeted in 2021 for this project. Also, the Township will receive \$12,100 from the Addisville Commons Development for the construction of a sidewalk beside the Addisville Cemetery property, and has an additional \$91,677 remaining in its sidewalk account, for a total available balance of \$623,777.

The Township received a \$50,000 grant for the Administration Front Walkway replacement from the Economic Development and Community Development Initiatives Program. The purpose of this grant is to provide handicapped access to our building for residents and other persons that need to visit our building to apply for permits, visit our Parks and Recreation Department, attend Township meetings or have general concerns. Improvement to this walkway will not only improve public access but it brings the Township into ADA compliance, as well as providing a safe entryway for visitors and employees.

The Township is looking forward to these improvements to continue making Northampton a great place to "live, work, and raise a family."

#### James E. Kinney Senior Center

The Northampton James E. Kinney Senior Center participated in a virtual project organized by the PA Governor's Office called, *One Lens: Sharing Our Common Views. One Lens* is a virtual photo and storytelling exhibition to give each and every Pennsylvanian the opportunity to share their COVID-19 stories through photography. *One Lens* is our chance to show what it is like to experience this extraordinary moment in history. Because art has the power to heal us, and by telling our stories, we can honor our efforts during this time, recognize our achievements, and help sustain each other as we continue the fight.

The senior center staff, wanted to showcase our efforts WITH our members but since we are unable to be together, we showcased our efforts FOR our members and the community. We submitted five photos with captions and a brief "story" for each. All five photos were included in the online exhibit.






