For all occupancies and Use Groups 12,001 sq. ft. to 18,000 sq. ft.	\$150.00
For all occupancies and Use Groups 18,001 sq. ft. to 24,000 sq. ft.	\$200.00
For each and every additional 12,000 sq. ft. or portion thereof, beyond 24,000 sq. ft.	\$50.00
