- *Any glass within 24 inches of a door (either side)*
- *Any window behind a tub or shower up to 60" above the floor*
- *Any window within 36 inches of a stairway, landing, or ramp up to 60 inches above the floor*
- *Picture windows – one piece of glazing over 9 square feet, less than 18 inches to finished floor*
- *All glass in doors, except jalousies*
- *Skylights, 4 square feet or less, and any part of the glass not more than 12 feet above the floor. If over 12 feet above the floor, laminated safety glass required. (This is special order.)*
- *Any window within 60 inches of a spa or swimming pool*
- *For any specific questions, please contact a building inspector.*
